First evaluation (Existing market)

Minimum and basic requirements to qualify as an applicant in Panama

- 1) Applicant must be at least 18 years old at the time of application.
- 2) The applicant must be a Panamanian citizen.
- 3) Applicant must be an honest DXN distributor and a full-time DXN member.
- 4) Applicant must have minimum Star Diamond (SD) status or higher.
- 5) The applicant must consider a minimum required distance of at least 5 to 10* km to the nearest Authorized Service Center. This must be a real tested distance.

Note: DXN may apply exceptions to the minimum distance requirement of 5 to 10 km when it believes that a Service Center is not complying with its obligations. When this exception applies, DXN will inform the applicant in advance.

- 6) The applicant must have at least 100 - 150 active downlines in their organization belonging to the area.

Note: Active members refer independent distributors who monthly make their qualification scores (30ppv or 100ppv), active event participants, etc. Not just consumers.

- 7) The applicant must have the ability to train and have taken all 6 Basic Training Modules.

The applicant must have the ability to make a minimum product purchase in the amount of B/.10,000 (the first purchase must contain each of the DXN products, promotional packages and as well as the membership kit).

Note: The amount may vary depending on the existence of new products on the market.

- 8) The applicant must not represent any other person in this application.
- 9) The applicant must have no criminal record or debts.
- 10) The applicant must meet all the basic requirements mentioned above.

Required documents:

1. Copy of current Panamanian ID in color.
2. Copy of proof of residence (telephone bill, electricity bill, etc.)
3. A specified letter with all the reasons for opening a Service Center.
4. Service Center Application - first and second evaluation form (request document at DXN Panama headquarters) duly completed. Remember that it must contain the signatures of the applicant and the person recommending the application.
5. A map of the location which should show the nearest banks etc...
6. Internal design with a measurement of each area.
7. Police report valid for one month from the presentation of the documents.
8. Affidavit of address/Notice of Operations.
9. Clear image of the possible place to rent if the application is approved*. Images must be from all areas, example: training area, warehouse area, sales area, etc.
10. Last 6 monthly bank movements, which must demonstrate that you are financially stable and have good cash flow, the amount of which must fluctuate between B/. 5,000 dollars per month.
- eleven. Purchase order indicating the products you wish to purchase in your initial purchase (minimum purchase of B/. 10,000).

*The company does not approve or encourage the applicant to rent the place or area prior to the approval or outcome of the application.

Location requirements:

The proposed location should be considered as a potential business, based on the following factors:

- a) Presence of bank offices.
- b) Availability of Telecommunications Company services in the area (telephone and internet providers).
- c) It must be on the first floor in an area with access to a wide street/avenue that allows the dispatch and stowage of merchandise through medium load vehicles, from Monday to Saturday with a minimum of 8 working hours and must comply with the corresponding regional or district regulations.

In addition, the proposed location must be in an area that is considered a center of business activity (for example, an area where various commercial activities take place and ensures a constant influx of public), direct access to public transportation and that allows adequate access to freight vehicles transporting DXN products.

Facilities required:

The proposed Service Center must have the capacity to provide the required basic facilities, listed below.

- 1) Surface of at least 100 m² with space for:

- to.Product display
- b.Sales / Display
- c.Training room/meeting area minimum where you can easily fit a
of 50 people.
- d.Warehouse/storage area
- and.Lavatory

2)Must be equipped with:

- to.Telephone, fax, printer and scanner.
- b.Acrylic board (with markers and erasers)
- c.TV/VCD/DVD
- d.Computer with internet access
- and.Product advertising
- F. Chairs
- g.Ventilation system in the sales and training area.
- h.Projector machine

Note:*The proposed area will be subject to visual inspection.*
